

ELECTION SCHEDULE FOR THE ELECTIONS 2026-28

In compliance with Trade Organizations Act(Amendment) 2022 & Trade Organizations Rules, 2013 Rule 14 and Article 15 of FWCCI Memorandum and Article of Association; the Executive Committee has approved the election schedule for the year 2026-28 against the vacant seats Corporate Class X 8, Associate X 8; on 07 July, 2026.

2.	The Changes, if any, regarding name of representative appearing in the list of provisional voters shall be sent to the Secretary General of the Women Chamber alongwith necessary proof of eligibility.	Saturday 11 July, 2026
3.	The Secretary General shall display the provisional list of all members eligible to vote along with their national tax, sale tax registration number if applicable with the name and national identity card number of their representative. (at notice board & web site of the Women Chamber).	Wednesday 15 July , 2026
4.	The members who have any objection to the entries/change on the list of provisional voters shall send their objections in writing to the Secretary General.	Wednesday 22 July, 2026
5.	The Secretary General will intimate action on the objection of changes sent by members.	Saturday 25 July , 2026
6.	Any person aggrieved by the decision of the Secretary General may make a representation to the election commission.	Tuesday 28 July, 2026
7.	The election commission shall decide the case.	Friday 31 July , 2026
8.	Any person aggrieved with the decision of the commission may appeal to the Regulator.	Tuesday 04 August, 2026
9.	The REGULATOR shall decide the case whose decision in this regard shall be final.	Saturday 15 August, 2026
10.	The final list of the voters shall be displayed at the notice board and at the website of the Women Chamber and also submit to REGULATOR.	Tuesday 18 Aug, 2026
11.	Any person who is eligible to contest the Election for the vacant posts of the member executive committee shall send her nomination papers duly proposed, seconded by a duly registered voter and signed by the candidate, to the Secretary General on the prescribed form in accordance with the Article of Association or rules of the Women Chamber.	Saturday 22 August, 2026
12.	A copy of final list of voters shall be provided to each contesting candidate by the Secretary General.	Monday 24 Aug , 2026
13.	Scrutiny of the nomination papers by the commission.	Tuesday 25 August , 2026
14.	The list of nominees whose papers have been declared valid to be displayed on the notice board and the forms of withdrawal to the said nominees to be issued.	Wednesday 26 August , 2026
15.	The objection if any, to the nomination of candidates can be filed to the election commission.	Friday 28 August , 2026
16.	The election commission shall decide the objections filed under the preceding clause.	Monday 31 Aug , 2026
17.	Any candidate aggrieved by the decision of the election commission may file an appeal to the Regulator.	Wednesday 02 Sept, 2026

18.	The Regulator Trade Organizations shall decide the appeal referred under the preceding clause.	Wednesday 09 Sept, 2026
19	Election Commission shall issue final list of the Candidates who are eligible to participate in the election.	Friday 11 Sept, 2026
20	Date of receipt, by the Secretary General of the withdrawal forms completed by the nominees who want to withdraw from the Election.	Tuesday 15 Sept, 2026
21.	Display & issuance of final list of candidates for the Election for all the members who are eligible to participate in the election.	Thursday 17 Sept, 2026

25	Any elected member of Executive Committee shall send his nomination for election as an office bearer duly proposed and seconded by an elected E.C. member and signed by the candidate to the election commission.	Thursday 24 Sept, 2026
26	Scrutiny of the nomination papers for the election of the office bearers by the Commission & display of contesting candidates on notice board.	Friday 25 Sept, 2026
27.	Polling for the election of office bearers.	Monday 28 Sept, 2026
28	Incompliance with Trade Organizations Act 2013, Rule (19) and FWCCI Memorandum and Article of Association, Article 69, The final result of the election of members -of the Executive Committee and office bearers shall be officially announced at the Annual General Meeting of the women Chamber called for this purpose.	(AGM) Tuesday 29 Sept, 2026

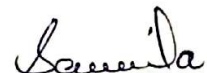
Polling hours will be from 9:00 A.M to 5:00 P.M with break for lunch and prayers from 1:00 P.M to 2:00 P.M
